2. PLEASE CAUSE THE IMMEDIATE TRACE OF THE FOLLOWING:

- THROUGH 8.
- 3. ALSO SEIZED WERE APPROXIMATELY 5,000 ROUNDS OF 5.56 MM AMMO, 500 ROUNDS OF .45 CAL AMMO, AND 150 ROUNDS OF .30 CAL AMMO.

4. INITIAL INFORMATION INDICATES THIS ARSENAL WAS SMUGGLED IN BY NARCO-GUERRILLAS THROUGH ECUADOR.
