1. REFERENCE IS MADE TO PRIOR TELCONS AND CABLES BETWEEN THE PEA BOGOTA C.O. AND DEA HQS REGARDING THE ESCAPE OF PABLO ESCOBAR FROM ENVIGADO PRISON IN COLOMBIA ON 7-22-92, AND THE SUBSEQUENT EFFORT TO LOCATE AND RECAPTURE ESCOBAR (OPERATION ENVIGADO).

2. THE DEA BOGOTA C.O. REQUESTS THAT DEA HQS COORDINATE THE AUTHORIZATION OF A REWARD IN THE SUGGESTED AMOUNT OF 500,000.00 (FIVE HUNDRED THOUSAND DOLLARS) TO BE PAID FOR INFORMATION THAT RESULTS IN THE CAPTURE OF PABLO ESCOBAR, NOTORIOUS DRUG TRAFFICKER AND VIOLENT TERRORIST. THIS REWARD WOULD NOT BE PAYABLE TO U.S. GOVERNMENT, COLOMBIAN GOVERNMENT OR POLICE AND/OR MILITARY PERSONNEL, BUT WOULD BE UTILIZED TO PROVIDE INCENTIVE TO CIVILIAN SOURCES IN COLOMBIA, AND OTHER COUNTRIES, TO EXPEDITIOUSLY COME FORWARD WITH ACTIONABLE INFORMATION THAT CAN BE IMMEDIATELY FORWARDED TO APPROPRIATE AUTHORITIES.

3. THIS REWARD, IF AUTHORIZED, WOULD BE CLOSELY COORDINATED WITH COLOMBIAN AUTHORITIES AND APPROPRIATELY PUBLICIZED WITHIN COLOMBIA VIA TELEVISION, RADIO AND HANDBILLS.

4. THE SWIFT APPREHENSION OF ESCOBAR, OR AT LEAST THE PLACING OF ESCOBAR IN A POSITION OF EXTREME DISADVANTAGE, MAY PRECLUDE THE WIDESPREAD TERRORIST

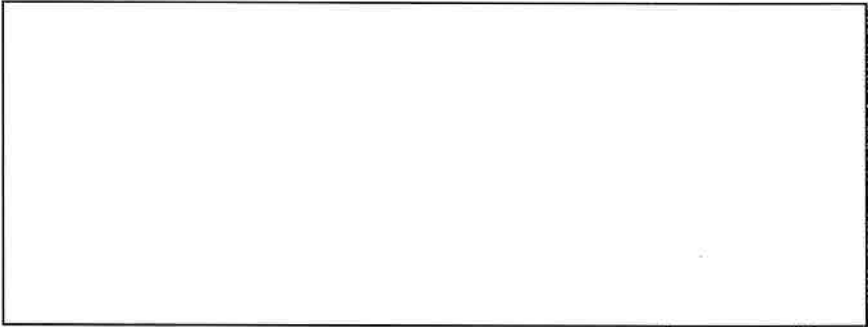
