2. THE COLOMBIAN NATIONAL POLICE, MEDELLIN SPECIAL TASK FORCE LEADER HAS ADVISED THE BOGOTA COUNTRY OFFICE THAT FOUR OF THE CALI PEOPLE KILLED IN MEDELLIN WERE KILLED AT THE ORDERS OF PABLO ESCOBAR GAVIRIA. THESE PEOPLE WERE WORKING FOR THE MEDELLIN CARTEL BY (b)(7)(C) ON MEMBERS AND ASSOCIATES OF THE CALI CARTEL. THESE PEOPLE HAD ASSISTED THE MEDELLIN CARTEL IN THE MASSACRE OF EIGHTEEN PEOPLE ON 26 SEPTEMBER, 1990 AT HACIENDA LOS COCOS, NEAR THE MUNICIPALITY OF CANDELARIA, VALLE DEL CAUCA. FOR DETAILS REF. BOGOTA CABLE 015634 DTG 282247Z SEP 1990. IN REFERENCE CABLE IT WAS REPORTED THAT HACIENDA LOS COCOS WAS OWNED BY (b)(7)(C) BUT FURTHER INVESTIGATION REVEALED THAT IT IS OWNED BY CALI CARTEL MEMBER (b)(7)(C)

THIS TIME, ESCOBAR HAD BEEN ADVISED THAT THE COLOMBIAN NATIONAL POLICE HAD LEARNED THE IDENTITIES OF THE FOUR PEOPLE AND WERE PLANNING TO ARREST AND QUESTION THEM. ONCE THE FOUR PEOPLE ARRIVED AT THE HOTEL IN MEDELLIN, ESCOBAR HAD THEM ASSASSINATED TO INSURE THEIR SILENCE. TO DATE, THE FOUR PEOPLE HAVE NOT BEEN IDENTIFIED, AS THIS GROUP OF FOUR IS ONLY A PARTIAL NUMBER OF PEOPLE TAKEN FROM MEDELLIN HOTELS. TO DATE, THERE HAVE BEEN CONFLICTING REPORTS AS TO THE TOTAL AMOUNT OF KIDNAPPING/MURDERS BUT THE NUMBER IS AS HIGH AS FOURTEEN. BCO WILL REPORT ADDITIONAL DETAILS WHEN AVAILABLE.

4. ON 26 OCTOBER, 1990 THE CNP IN BOGOTA REPORTED THE DEATHS OF THREE PEOPLE IN WHAT APPEARS TO BE DIRECTED TOWARD THE MEDELLIN CARTEL. THE THREE, TWO MEN AND A WOMAN, WERE FOUND ASSASSINATED IN A RESIDENCE LOCATED IN THE NORTHWEST SECTION OF BOGOTA. THE MEN WERE IDENTIFIED AS JHON JAIRO ALZATE JARAMILLO AND JESUS ARENAS GUTIERREZ, THE WOMAN IS STILL UNIDENTIFIED. RECOVERED AT THE SCENE WERE APPROXIMATELY 69 KILOGRAMS OF DYNAMITE AND A GRENADE. WRITINGS ON THE WALLS STATED "THESE PEOPLE ARE ASSASSINS FROM MEDELLIN. REGARDS TO (b)(7)(C) IF YOU WANT WAR, WE HAVE WAR". (b)(7)(C) IS AN ALIAS/NICKNAME USED BY (b)(7)(C) (b)(7)(C) AN ASSASSIN WORKING DIRECTLY FOR ESCOBAR.

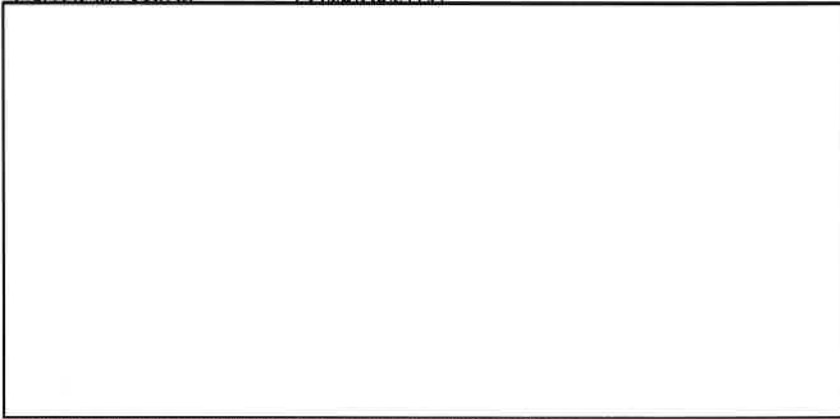
