5. IN ADDITION TO THE ABOVE, LAST WEEK (8-11-91 THRU 8-17-91), THE SCHOOL THAT (b)(7)(C) DAUGHTER ATTENDS WAS THREATENED ON TWO OCCASIONS BY AN UNIDENTIFIED CALLER. IN SUMMARY AND ACCORDING TO (b)(7)(C) THE CALLER ADVISED SCHOOL OFFICIALS THAT THEY WANTED THE (b)(7)(C) DAUGHTER AND THAT IF SHE WAS NOT TURNED OVER TO THEM, THEY WOULD DYNAMITE THE SCHOOL. HOWEVER, NO ACTIONS WERE TAKEN BY THE TERRORISTS. IT SHOULD ALSO BE NOTED THAT THE CHILDREN OF TWO OTHER (b)(7)(C) ATTEND THIS SAME SCHOOL AND THAT IT IS UNKNOWN IF THESE (b)(7)(C) CHILDREN WERE THE INTENDED TARGETS OF THIS THREAT).

6. IT IS BELIEVED THAT (b)(7)(C) HAS BEEN TARGETED BY THE MEDELLIN CARTEL BECAUSE OF HIS HIGHLY VISIBLE AND VOCAL REMARKS CONCERNING SEVERAL RECENT WEAPONS SEIZURES MADE IN MEDELLIN AND CALL. ALTHOUGH (b)(7)(C) DID NOT SPECIFICALLY ALLEGE THAT THE NARCOTRAFFICERS WERE SUCCESSFULLY OBTAINING HIGH TECH-HIGH POWERED WEAPONS, HIS REMARKS, VISIBILITY AND INVOLVEMENT IN EXPOSING THESE FACTS IDENTIFY HIM (b)(7)(C) NARCOTRAFFICKERS WEAPONS PRECUREMENTS.
