RESUMES

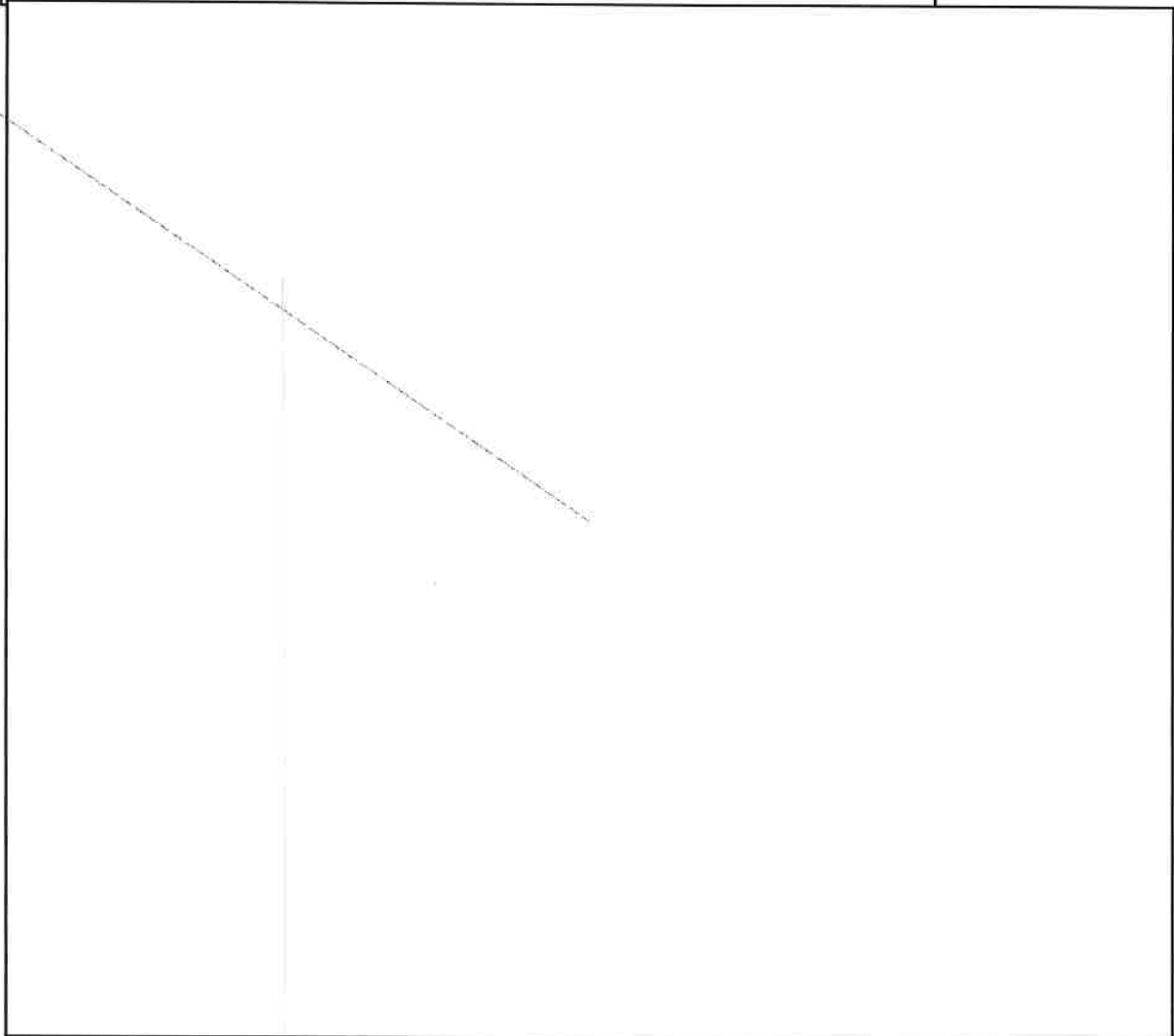
-- (U) THE 15 APRIL CAR-BOMBING, WHICH DEVASTATED THE CENTRO 93 SHOPPING CENTER IN BOGOTA, REIGNITED THE VIOLENCE BETWEEN THE PABLO ESCOBAR ORGANIZATION AND PERSECUTED BY PABLO ESCOBAR (PEPE) VIGILANTES. THE EVENING FOLLOWING THE CAR-BOMBING, PEPE DESTROYED 4 RESIDENCES IN MEDELLIN. THEY ALSO KIDNAPPED AND MURDERED ESCOBAR S ATTORNEY, GUIDO PARRA MONTOYA AND HIS ELDEST SON. TWO AND A HALF HOURS AFTER ARMED INTRUDERS KIDNAPPED MONTOYA AND HIS SON FROM THEIR MEDELLIN APARTMENT, THEIR BODIES WERE FOUND IN THE TRUNK OF A VEHICLE ABANDONED IN THE OUTSKIRTS OF MEDELLIN. MONTOYA, AS PABLO ESCOBAR S CHIEF LEGAL COUNSEL, NEGOTIATED THE DRUG KINGPIN S SURRENDER TO

COLOMBIAN AUTHORITIES IN 1991.
