A. (U) COLOMBIA: ON 11 AUG, COLOMBIAN POLICE KILLED GUSTAVO GAVIRIA, THE NUMBER TWO LEADER OF THE MEDELLIN COCAINE CARTEL AND COUSIN OF CARTEL BOSS PABLO ESCOBAR, DURING A SHOOTOUT IN MEDELLIN. GAVIRIA WAS PREVIOUSLY IDENTIFIED BY ESCOBAR AS HIS SUCCESSOR IN THE EVENT OF ESCOBAR'S UNTIMELY DEATH. ON 13 AUG, UNIDENTIFIED GUNMEN SHOT DEAD A FORMER LIBERAL PARTY CONGRESSMAN IN CALI AND A FORMER HIGH COURT JUDGE IN BARRANQUILLA (APPROX 50 MILES NE OF CARTAGENA). A STATEMENT FROM "THE EXTRADITABLES," ALSO ON 13 AUG, CLAIMED THEY WOULD NOT BREAK THE TWO-WEEK-OLD TRUCE BECAUSE THEIR "DESIRE FOR PEACE IS UNSHAKEABLE." (OPEN PRESS)

ATAC COMMENT (C/NF): IT IS UNCLEAR WHETHER THE MURDERS ARE LINKED TO THE DEATH OF GUSTAVO GAVIRIA. THE LOCATION SUGGESTS THE KILLINGS ARE THE WORK OF THE CALI CARTEL AND THE NORTH COAST TRAFFICKERS, RESPECTIVELY, OR ARE REPRISALS BY LOCAL THUGS. IF PABLO ESCOBAR DECIDES TO RETALIATE FOR THE DEATH OF HIS COUSIN, IT IS LIKELY THE ATTACKS WOULD BE MORE NUMEROUS, WIDESPREAD AND DAMAGING, SUCH AS ATTACKING PATROLS OF THE ELITE POLICE CORPS IN BOGOTA AND MEDELLIN.
