1. AS PER PAST CABLES FROM THE DEA/BOGOTA COUNTRY OFFICE (BCO) TO DEA HQS. REFERENCE THE POSSIBLE SURRENDER ENMASSE OF MEMBERS OF THE CALI, MEDELLIN AND NORTH COAST CARTELS, THE BCO ADVISES THESE NEGOTIATIONS CONTINUE AND ARE, IN FACT, GAINING MOMENTUM.

2. BCO G/S BILL LEDWITH WAS ADVISED BY COLOMBIAN FISCAL GENERAL GUSTAVO DE GREIFF THAT A MEETING BETWEEN HIMSELF (DE GREIFF), PROCURADOR GENERAL CARLOS GUSTAVO ARIETA-PADILLA, MINISTER OF DEFENSE RAFAEL PARDO AND REPRESENTATIVES OF THE COLOMBIAN NATIONAL POLICE (CNP) AND DEPARTAMENTO ADMINISTRATIVO DE SEGURIDAD (DAS), WAS HELD ON MAY 5, 1993, IN BOGOTA REGARDING THE ONGOING SURRENDER NEGOTIATIONS OF CALI, MEDELLIN AND NORTH COAST CARTELS.

3. FISCAL GENERAL DE GREIFF FURTHER ADVISED THAT DESPITE EXTENSIVE LOCAL PUBLICITY AND STATEMENTS ATTRIBUTED TO PROCURADOR GENERAL ARIETA, NO LEGAL REPRESENTATIVES OF THE CARTELS WERE PRESENT AT THIS MEETING. DE GREIFF STATED THAT DUE TO THE INCREASING BURDEN OF THE NEGOTIATIONS REFERENCED ABOVE, HE ARRANGED THIS MEETING TO REQUEST THE ASSISTANCE OF THE ABOVE
