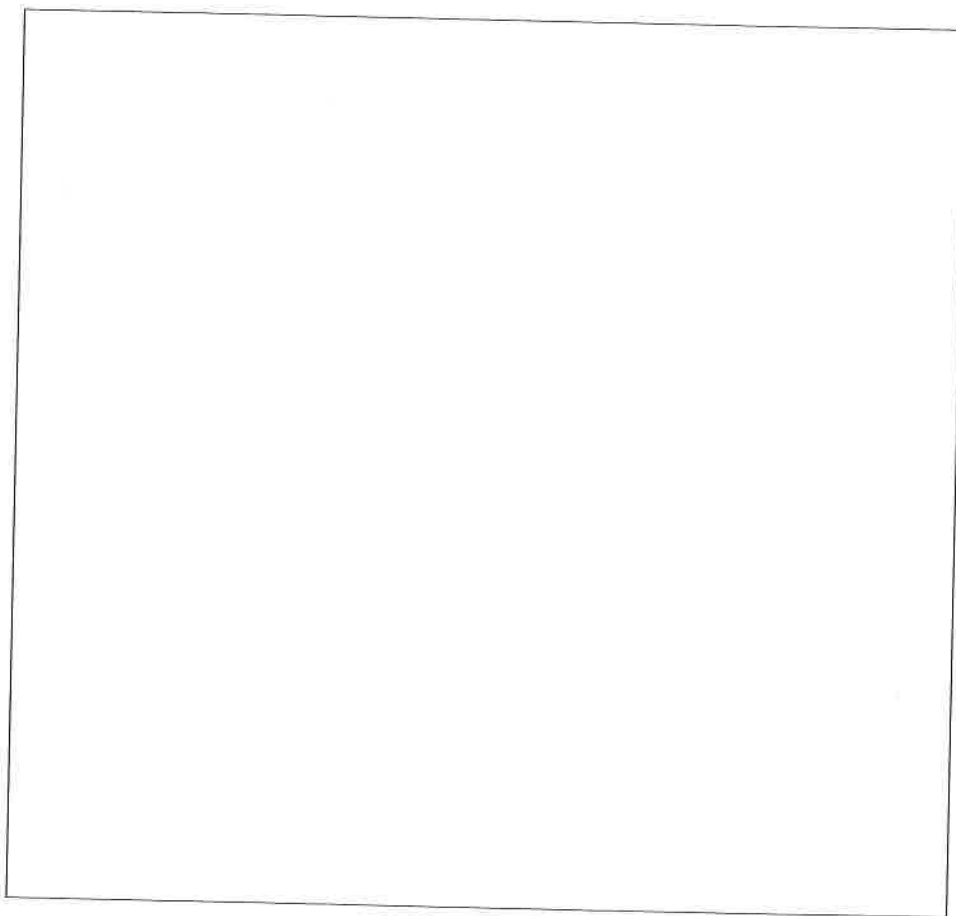

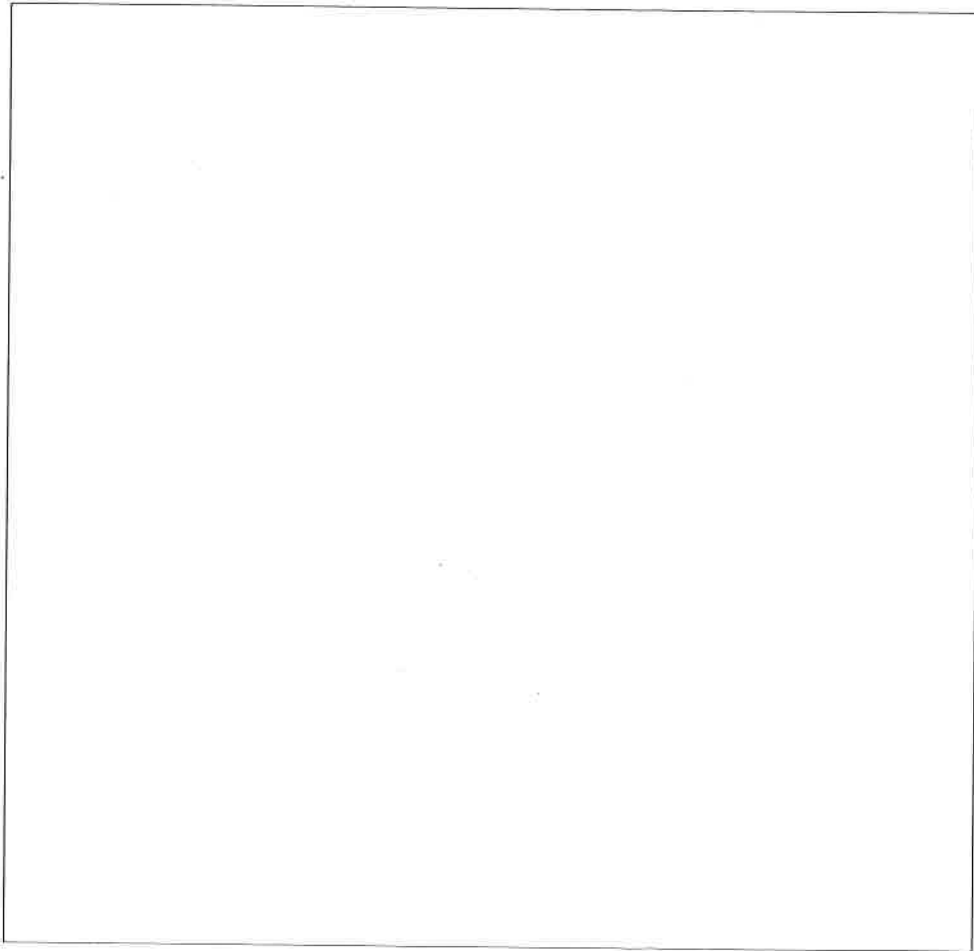

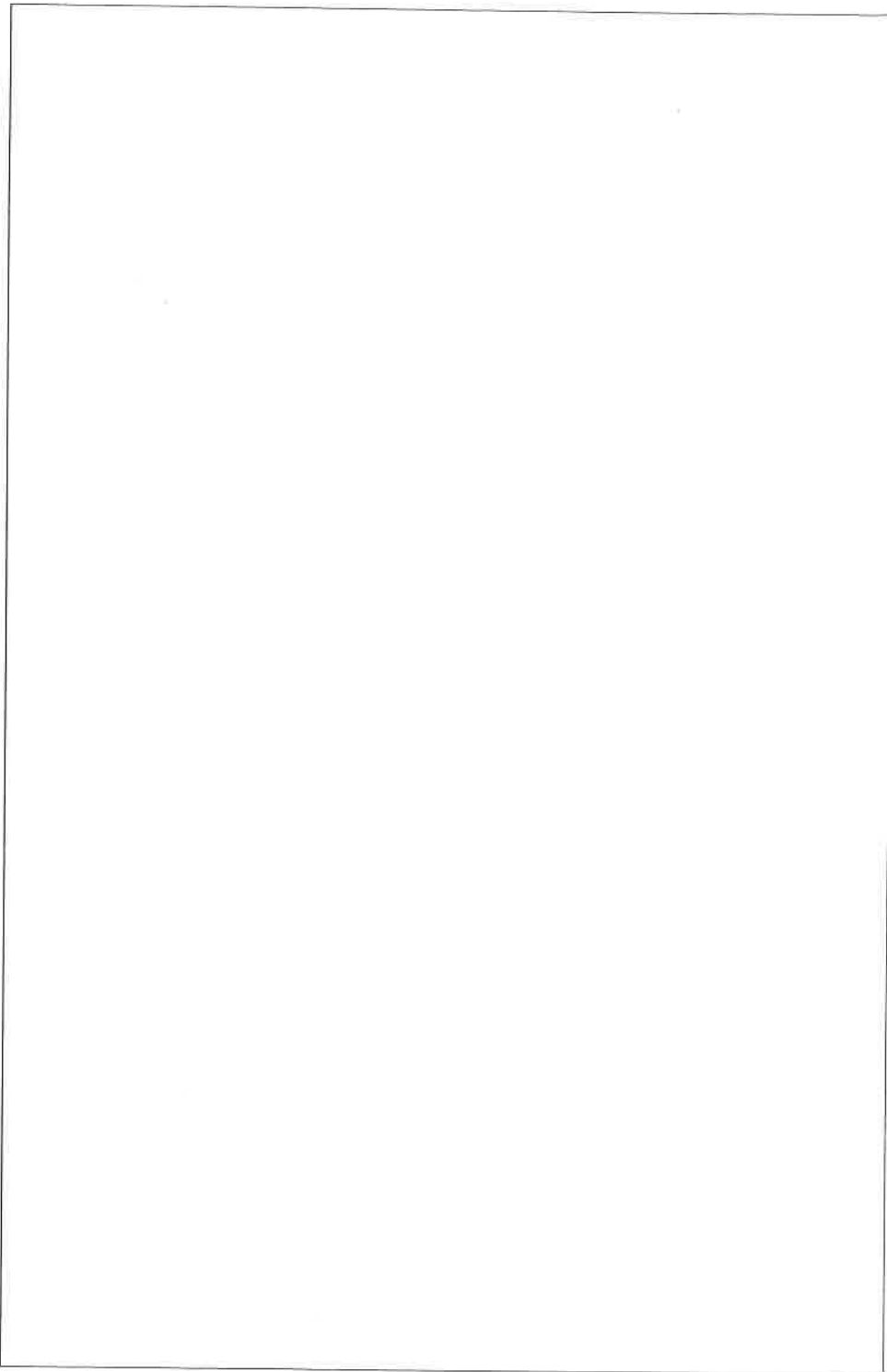

BEGINNING IN MID-NOVEMBER 1992, RIO GRANDE VALLEY LAW ENFORCEMENT PERSONNEL INCLUDING FEDERAL JUDGES AND ASSISTANT U.S. ATTORNEYS HAVE BEEN WARNED OF POSSIBLE ATTACKS AGAINST THEM BY THE MEDELLIN DRUG CARTEL. THE THREATS ARE ATTRIBUTED TO THE SEARCH FOR ESCAPED DRUG LORD PABLO ESCOBAR AND THE ESCALATION OF DRUG RELATED VIOLENCE IN COLOMBIA. REPORTS OF THE THREAT OF SUCH DRUG RELATED RETALIATORY ATTACKS COME FROM THE EL PASO INTELLIGENCE CENTER, THE U.S. DRUG ENFORCEMENT ADMINISTRATION, THE FBI IN SAN ANTONIO, AND ASSISTANT U.S. ATTORNEY MIKE MCCORMICK IN MCALLEN, TEXAS. DRUG TRAFFICKING FIGURES WITH COLOMBIAN CONNECTIONS ARE DETAINED IN PRISONS WITHIN POST S CONSULAR DICTRICT, THROUGH SOME WERE TRANSFERED TO OTHER AREAS AFTER MATAMOROS MAY 1991 PRISON RIOT.

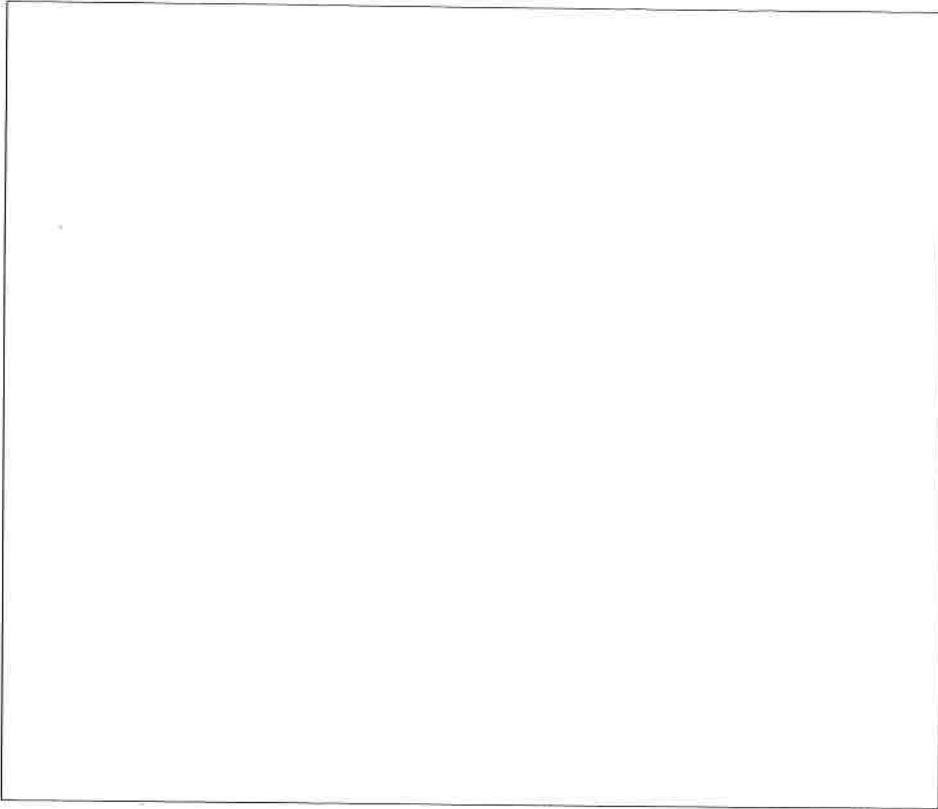

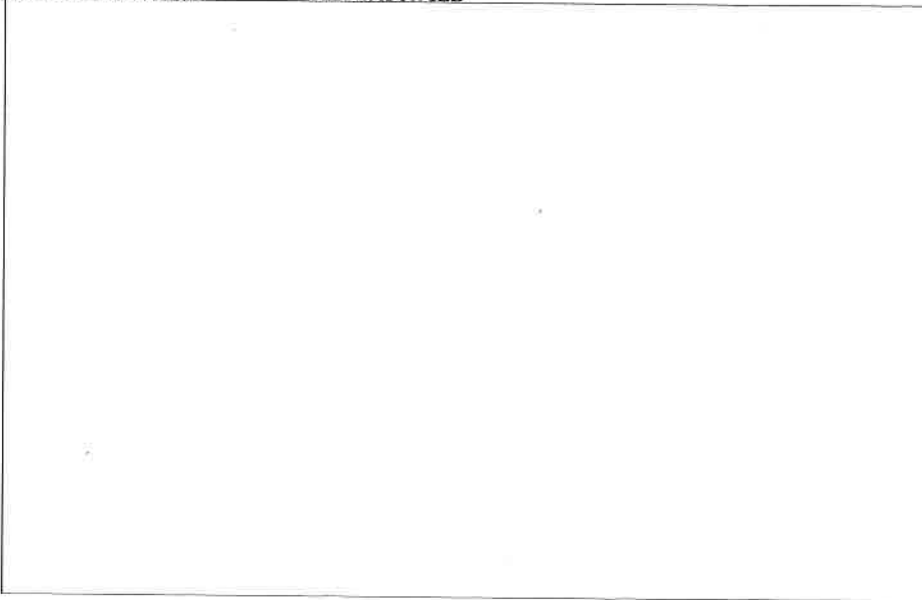
